SUMMARY OF REGULATION: This regulation is amended to reflect that degrees may be awarded pursuant to bachelor's and master's programs approved by the UCF Board of Trustees and doctoral programs approved by the Florida Board of Governors. The awarding of Associate of Arts degrees has been added to the regulation. Technical changes have been made, including renumbering and renaming the regulation.

FULL TEXT OF THE PROPOSED REGULATION AMENDMENT:

~~6C7-UCF-2.010~~ **Awarding of Degrees.**

(1) Earned degrees shall be awarded upon the recommendation of the appropriate Dean and the ~~Vice President of Academic Affairs~~Provost. These degrees shall be limited to those

awarded pursuant to degree programs approved by the University of Central Florida Board of Trustees, for bachelor's and master's programs, and the Florida Board of Governors, for doctoral programs. Additionally, the university may award the Associate in Arts (A.A.) to eligible students upon completion of the appropriate requirements and application.

(2) The curricular requirements for each University program shall be those delineated in the Undergraduate or Graduate Catalog, as appropriate, University bulletin in force at the beginning of the student's most recent period of continuous ~~attendance~~enrollment.

(3) Honorary degrees may be awarded by the ~~President~~Board of Trustees upon the recommendation of the ~~Vice President of Academic Affairs~~President.

(4) The University may award posthumous and emeritus degrees in accordance with university policies and procedures.
